You are welcome to send us your invoices in PDF format via email. Receiving your invoices via EDI or in other electronic formats (e.g. ZUGFeRD, or similar) we at CLAAS favor even more. Please feel free to contact us to discuss the further procedure individually.

In order to ensure safe processing of invoices by email, please proceed as explained below:

1. Receiver's e-mail account

CLAAS entities hold an e-mail account exclusively for receiving invoices. Please enter this email address as the recipient (To) only. Please do not send it in copy (CC). You may find the respective e-mail account attached in Annex 1 (page 1 / 2) at the end of this document (e.g. InvoiceCSE@CLAAS.com).

2. Formal requirements

Please send **one single e-mail for each invoice** (e.g. 5 invoices = 5 e-mails).

The mail may contain only one attachment in addition to the invoice, but an attachment is not mandatory. Please notice to send the invoice and the corresponding attachment within the same email.

3. Format requirements

Invoice and optional attachment need to be in ***.PDF format**.

The following guidelines apply to the naming of the documents:

- a. The **invoice** (document name) may **not begin with A**

Examples for the correct naming of the invoice:

123456.pdf

invo8999.pdfb.

- b. The **attachment** is always an enclosure and **must begin with A**

Examples for the correct naming of the attachment:

Attachment4711.pdf



- c. The file names for invoice and attachment may contain maximum 25 characters.
